## Essentially a statement of values, policy will help guide direction on new resources

**Portland, Oregon - 01/23/2008** - The Board of Directors of PNGC Power has given their support to a climate change policy to meet current and future load growth, and directed staff to evaluate energy resources that are diverse, reliable, efficient and economically and environmentally sustainable. This past summer the Board passed a resolution strongly supporting the clean, renewable hydro system in the Northwest. Portland-based PNGC Power and its 15 Northwest electric distribution cooperative utilities have service territory in seven western states.

According to Rick Crinklaw, Chairman of the PNGC Power Board and General Manager of Lane Electric Cooperative, Eugene, Oregon, "We have been planning for the future since PNGC Power was created. We recognize that careful stewardship of the environment through our operations is both good business practice and the right thing to do. The climate change policy provides additional direction during a time of change."

"Electricity generated by the hydropower system is clean, renewable and supplies over twothirds of our region's current energy needs," said John Prescott, President and CEO, PNGC Power. "As the regional demand for electricity continues to grow it is important to retain those environmental and economic benefits while exploring other sustainable resources to meet our loads, now and in the future."
